

# REEDLEY CERTIFIED FARMERS' MARKET



**Sponsored by the Reedley Downtown Association**

1. The market will be open from 4:00 p.m. to 7:00 p.m. on Wednesdays, beginning May 19th, 2010 through Aug. 25th, 2010.
2. Commodities sold are Fresh Fruits, Vegetables, Dried Fruits, Fresh & Dried Herbs, Fish, Nuts, Honey, Eggs, House Plants and Fresh Cut Flowers
3. RDA Merchants may also sell products that compliment their business with pre-approval of RDA Board of Directors; Market fees are waived for RDA Members.
4. All other products and sellers must have approval from the RDA Board prior to selling and must meet State regulations for their sale.
5. Market space fees are 10% of gross sales, minimum \$10, not to exceed \$20, payable at the end of each market.
6. Each grower participating in the market must provide the market manager with a copy of his/her certified producer certificate and a signed copy of market rules.
7. All commodities sold at the market shall meet the requirements of the California Food and Agriculture Code. For commodities that must be weighed, scales or balances are required, and must be "sealed" by the county sealer of weights and measures.
8. Peddlers are not permitted to sell at the market. No resale of any commodities may be made, and no commission will be paid or received in connection with sales EXCEPT RDA MEMBERS with prior approval of the RDA Board of Directors.
9. Growers must accept the space assigned. Spaces will be assigned the day of the market; first come first assigned basis. Each space is approximately 10' x 10' and located on the street; not on the sidewalk.
10. Growers must maintain the space assigned in a clean and sanitary condition, and when vacating must remove from the premises all equipment, fruit, vegetables, trimmings, wrappings and containers. Previously stated "waste" must be properly disposed of by each grower; no disposing of in the trash receptacles along the sidewalk on G Street.
11. Products may be sold by the grower, a member of his/her immediate family, or a paid employee. One certified producer may act for and sell the products of two other certified producers with the approval of the RDA Board of Directors.
12. Collusion among growers to raise prices or exertion of any influence, pressure or persuasion to cause a grower to increase prices are strictly forbidden.
13. Any variation from the foregoing regulations will preclude a grower's right to sell at the market. The RDA has the authority to enforce these regulations to exclude nonconforming growers.
14. The Reedley Certified Farmers' Market is run in a fair, equitable and non-discriminating manner and participants must abide by all governing city and county regulations.
